- 1 Passport must be valid for at least 6 months with 3 or 4 blank visa pages. Non-US applicants must submit a valid Permanent Residency Card (Green Card) with their native Passport.
- 2 4 Passport-Type Photographs (**White Background**).
- 3 Vaccination Certificate against **Meningitis and FLU shot**.
- 4 Completed and signed Saudi Hajj Visa Application form.
- 5 Ladies traveling without a Mahram must provide the proper proof of a relationship (marriage certificate for married couple) (Shall be NOTARIZED)
- 6 Hajj fees (\$300.00) in money order issued to "UNIFIED AGENTS OFFICE".
- 7 Non-US Citizens must apply to obtain Visa for European Countries & the Middle East.
- 8 The Islamic Center of San Gabriel Valley is not responsible for any person traveling on a different schedule than the group in regards to missing flight connections, lost luggage, or delay in immigrations check in Saudi ports.
- 9 All applications shall be submitted no later than August 2, 2014.
- 10 Zabiha/Qurbani \$140.00
- 11 Any Registration after August 2, 2014 may get increase in Airline fee/taxes

7: Payment Policy:

A \$2,000 deposit per person to be paid at registration. Deadline of registration August 2, 2014. Final day to accept full payment is due on August 2, 2014.

8: Cancellation Policy:

All cancellations before August 2, 2014 will be assessed a \$2,000 charge per person. No refunds for cancellations after August 2, 2014. All cancellation shall be in writing by registered mail and/or email.
